

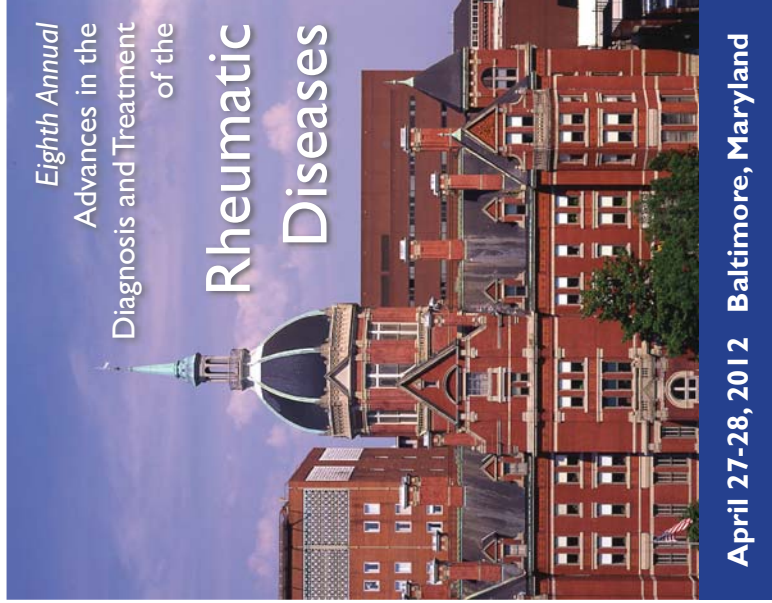

Eighth Annual Advances in the Diagnosis and Treatment of the Rheumatic Diseases

Description

Now in its eighth year, this two-day symposium has been planned for the providers of care to patients with rheumatic diseases. Given the wide variety of rheumatologic disorders, and an ever-increasing number of diagnostic procedures and treatment options, it is necessary to provide clinicians with information about strategies for the early diagnosis of these conditions, novel state-of-the-art diagnostic tools, and opportunities to utilize the most effective treatments to ensure optimal patient outcomes.

Who Should Attend

This activity is intended for rheumatologists, internists, gerontologists, orthopedic surgeons, nurses and other allied health professionals.

Objectives

After attending this activity, the participant should be able to:

- Review new guidelines in the diagnosis and treatment of rheumatic diseases
- Discuss the use of biologic agents in the treatment of rheumatoid arthritis
- Appreciate new treatment options for patients with psoriatic arthritis
- Discuss new and emerging issues in the management of osteoporosis
- Identify major issues related to the management of vasculitis
- Appraise current management approaches and controversies in the diagnosis and treatment of ankylosing spondylitis
- Discuss treatment strategies in systemic lupus erythematosus

- Review current treatment of the scleroderma patient
